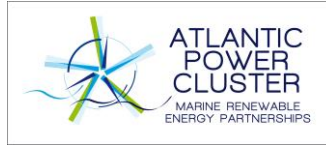

- *Before the visit starts, the guide will indicate the route to the marine energy plant, noting that is not allowed to divert of it during the visit.*
- *All tours are limited to a maximum of 25 people per group who will at all times be accompanied by the guide during the same. Under no circumstances will any visitor access the platform elevation 16.50, since that has no railing at all stages and there is a risk of falling from heights.*
- *The access will take place through the cabin built for the purpose, from which the operation of the plant will be shown during the tour.*
- *The accidents that may occur in the course of the visits by any visitor's carelessness will not be the responsibility of the organizers.*
- *The organization reserves the right to modify or cancel the visit*
- *In case of cancellation, changes in itinerary or duration of the visit, through no fault of the organization (weather pe), the amount paid will not be refunded and a new date will be agreed with the organization.*
- *For any matter arising from the interpretation or application of the conditions contained in this document and to fulfill the obligations of the acceptance thereof is derived, both the visitor and the organizer are subject to the jurisdiction of the Bilbao courts, waiving any other jurisdiction.*
